INVITATION

Dear Secretary General,

Taking into account the very short deadlines for inviting riders to participate at the 2008 HSBC FEI World Cup™ Final in Deauville (FRA), we would be very grateful if you can provide us with information as to your participation.

The current standing now includes Martinvast FRA and the 2 last events will be held this week-end 28-31 August (Schenefeld GER & Moscow RUS). The final rankings of the HSBC FEI World Cup™ for the 2008 HSBC FEI World Cup™ Final in Deauville (FRA) will therefore be published **1 September 2008**.

According to the Rules, riders will be qualified to participate in the final according to their final ranking and subject to a quota per nation:

Max 6 riders from each nation	AUS – GBR – USA – NZL – FRA - GER
Max 5 riders from each nation	IRL - SWE
Max 4 riders from each nation	BEL – BRA - ITA
Max 3riders from each nation	All other nations

The maximum quota for participation is maximum 40 riders. In the final a competitor may only ride one horse.

The defending Champion Nicolas Touzaint FRA is invited as an extra competitor not counting for the national quota.


